# TOWNSHIP OF GREENWICH LAND USE BOARD AUGUST 5, 2024 REGULAR MEETING MINUTES

-App 6-2024, Chuck & Peggy Mazza, 881 Ye Greate Street, Bl 18, Lot 19, (Historic); Ms. Mazza stated that it is a 32' picket fence purely for aesthetics. It will use posts and concrete and will have a little gate. The fence will span between two sets of hedges. Mr. Henry asked where it would be located as to the right of way; the center line to shoulder is 18' plus 21' from the center of the road per Mr. Riley. Mr. Henry and Mr. Riley suggested that the applicant either check with the County for a road opening permit or move it back. Mr Henry also suggested looking at the survey that came with the house; the fence should not be closer to the road than the survey markers. Ms. Mazza stated that she will check the survey. (Note that this application has not yet been paid for and thus is not considered submitted, nor denied). Ms. Brecht-Mangiafico advised Ms. Mazza to determine the feasibility of placement before proceeding with a formal application.
