RESOLUTION REAPPOINTING KIM FLEETWOOD AS TEMPORARY CHIEF FINANCIAL OFFICER FOR THE TOWNSHIP OF GREENWICH EFFECTIVE JANUARY 1, 2019 FOR A ONE YEAR TERM

NJ ABC Regulation Changes – Mr. Carr reviewed the proposed regulations that if adopted will enable the municipality by ordinance to approve additional restaurant licenses.

Certified Local Government – Mr. Carr indicated that if adopted grant funds may be available for the Township. The Committee has request this to be placed on the next agenda for further review and discussion.

Grant Writer - Mr. Pisarski has volunteered his service, free of charge, to write a grant for the Fire Department.

Solicitor Report – Mr. Carr reviewed his report with the Committee. He indicated he had, at the direction of the Committee, sent correspondence to the Director of Local Government Services, requesting authorization to appoint Ms. Fleetwood for an additional term as Acting Chief Financial Officer. Mr. Carr further indicated the Uniform Fire Safety Ordinance will be available for introduction in January and adoption in February with an April 1st start date. Also the Committee directed Mr. Carr to reach out to the mayor of Hopewell Township in regards to the Registrar of Vital Statistics position to determine if they are still interested in continuing the shared service agreement for said position.

Committee Comments – Committeeman Werley reported that he had met with Mr. Neher, County Public Works, in regards to the Market Lane Dike project. He thanked the County as the project looks good. Mayor Reinhart mentioned that during the last full moon with the high tide the dike was about to go. Committeeman Werley indicated at the last Planning/Zoning Board meeting he felt the Board was too aggressive in regards to the Historic District as many people do not understand the process. After further discussion Ms. Garrison was directed to reach out to other areas to develop an instruction packet for applicants. The Committee on motion of Deputy Mayor Orr, seconded by Mayor Reinhart directed Ms. Fleetwood to encumber the balance of funds from Streets & Roads for the removal of tress on Tindall Island Road, unanimously carried. Mayor Reinhart reported on Thursday a meeting in regards to the new fire code regulations will be held in Hopewell. Mayor Reinhart indicated the overhead door at the fire department is rotten. On motion of Committee Werley, seconded by Deputy Mayor Orr to approve the quote from Elmer Overhead Door in the amount of \$1,275 to repair/replace said door, unanimously carried. On motion of Deputy Mayor Orr, seconded by Mayor Reinhart to accept the quote of John Mastalski in the amount of \$300.00 for brush removal, unanimously carried. Mayor Reinhart reported on the calls for the month of November as follows: 5 Fire Calls; 3 EMS Calls with a YTD amount of 124.

Public Comment

On motion of Mayor Reinhart, seconded by Deputy Mayor Orr to open the public comment, unanimously carried. Charles Reinhart thanked the Committee for the new fire truck and also their trust and support. Discussion ensued on the door at the fire department and Mr. Charles Reinhart was advised the Department would have to discuss this with the Planning/Zoning Board. There being no further comment forthcoming on motion of Deputy Mayor Orr, seconded by Committeeman Werley to close the public comment, unanimously carried.

Adjournment - On motion of Deputy Mayor Orr, seconded by Committeeman Werley to adjourn, unanimously carried.
