Each month, the Chief Financial Officer shall prepare a schedule of investments purchased and redeemed, investment earnings, fees incurred and market value of all investments.

The Government Unit Depository Protection Act approved banks located in the State of New Jersey and possessing a current government Unit Deposit Protection Act Eligibility Certificate issued by the New Jersey Department of Bank and Insurance are authorized depositories for the deposit of funds.

The CFO shall report to the governing body any account that does not earn interest.

SETTING INTEREST AND PENALTY ON PROPERTY TAXES

WHEREAS, under the provisions of N.J.S.A. 54:4-67 the governing body is authorized to fix the rate of discount for prepayment of property taxes or assessments and to fix the rate of interest for non-payment of property taxes or assessments on or before the date when they would become delinquent; and

WHEREAS, the aforesaid statute was amended to provide for the assessing of a penalty to be charged to a taxpayer with a delinquency in excess of TEN THOUSAND (\$10,000.00) DOLLARS; and

WHEREAS, pursuant to N.J.S.A. 54:4-66, it is provided that property taxes shall be payable in quarterly annual installments with the first installment due on February 1st, the second installment due on May 1st, the third installment due on August 1st and the fourth installment due on November 1st, after which dates, if unpaid, they shall become delinquent which statute also provides for the manner in which quarterly installments or property taxes shall be determined and received:

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Greenwich

- A. That no discount be allowed for prepayment of property taxes or assessments.
- B. That the rate of interest to be charged for the non-payment of property taxes or assessments on or before the date they would become delinquent, as fixed by statute, shall be Eight (8%) Percent per annum on the first ONE THOUSAND FIVE-HUNDRED (\$1,500.00) DOLLARS and Eighteen (18%) Percent per annum on any amount in excess of ONE THOUSAND FIVE-HUNDRED (\$1,500.00) DOLLARS to be calculated from the date the tax was payable to the date of actual payment, provided no interest shall be charged if payment of any installment is made within the tenth calendar day following the date upon which the same became payable; and
- C. In the event there is a delinquency in excess of TEN THOUSAND (\$10,000.00) DOLLARS at the end of the calendar year, then the Tax Collector is authorized to charge a penalty of Six (6%) Percent of the amount of the delinquency. The delinquency shall mean the sum of all taxes and municipal taxes due on a given parcel of property covering any number of quarters of years.

- D. That the provision of this Resolution shall remain in full force and effect until further action of the Township Committee.
- E. That a certified copy of this Resolution be filed with the Collector of Taxes.

PROPOSED ORDINANCE 40-2019

AMENDMENTS TO ORDINANCE NO. 9-13 AMENDMENTS TO AN ORDINANCE ESTABLISHING THE ENFORCEMENT OF THE UNIFORM FIRE SAFETY ACT

WHEREAS, the Uniform Fire Safety Act (P.L. 1983, c. 383) was enacted for the purpose of establishing a system for the enforcement of minimum fire safety standards throughout the State of New Jersey; and

WHEREAS, the Uniform Fire Safety Act authorizes municipalities to provide for local enforcement and to establish local enforcement agencies for the purpose; and

WHEREAS, it is in the best interest of the municipality of Greenwich Township to have the Uniform Fire Safety Act enforced locally; and

WHEREAS, all fire departments, fire companies and fire districts have agreed to the plan, which is set forth herein, for the administration and enforcement of the Uniform Fire Code:

NOW, THEREFORE BE IT ORDAINED AND ENACTED by the Mayor and Governing Body of the municipality of Greenwich Township in the County of Cumberland and State of New Jersey as follows:

1. <u>LOCAL ENFORCEMENT</u>

Pursuant to Section 11 of the Uniform Fire Safety Act (P.L. 1983, c. 383) and the New Jersey Uniform Fire Code, the local enforcing agency shall be The City of Bridgeton Bureau of Fire Prevention under the Shared Services Agreement entered into between the Township of Greenwich in Cumberland County and the City of Bridgeton and authorized by Greenwich Township Committee Resolution 1-15-2019 adopted on January 2, 2019.

2. **AGENCY DESIGNATION**

The local enforcing agency shall be the City of Bridgeton Bureau of Fire Prevention under the Shared Services Agreement entered into between the Township of Greenwich in Cumberland County and the City of Bridgeton and authorized by Greenwich Resolution 1-15-2019, adopted on January 2, 2019.

3. **DUTIES**

The local enforcing agency shall enforce the Uniform Fire Safety Act and the codes and regulations adopted under it in all buildings, structures and premises within the Township of Greenwich, other than owner occupied one and two-family dwellings used exclusively for dwelling purposes and buildings, structures and premises owned or operated by the Federal Government, Interstate Agencies or the State of New Jersey, and shall faithfully comply with the requirements of the Uniform Fire Safety Act and the Uniform Fire Code.

4. <u>LIFE HAZARD USES</u>

The local enforcing agency established by Section 2 of this Ordinance shall carry out the periodic inspections of life hazard uses required by the Uniform Fire Code on behalf of the Commissioner of Community Affairs.

5. **ORGANIZATION**

The local enforcing agency established by Section 2 of this Ordinance shall interact and cooperate with the Greenwich Township Fire Company and its Fire Chief who shall, in turn, report to the Greenwich Township Committee.

6. **APPOINTMENTS, TERM OF OFFICE, REMOVAL**

6A. The Fire Official appointed by the City of Bridgeton shall serve Greenwich Township pursuant to the Shared Services Agreement mentioned above.

6B. Term of Office

Pursuant to the aforementioned Shared Services Agreement, the Fire Official shall serve for the term set by the City of Bridgeton.

6C. Inspectors and Employees

Such inspectors and other employees as may be necessary shall be appointed by the City of Bridgeton pursuant to the Shared Services Agreement.

6D. Removal from Office

Inspectors and other employees of the enforcing agency and the Fire Official shall be subject to removal by the City of Bridgeton under applicable Bridgeton Ordinances.

7. **BOARD OF APPEALS**

Pursuant to Sections 15 and 17 of the Uniform Fire Safety Act, any person aggrieved by any order of the local enforcing agency (or agencies) shall have the right to appeal to the Construction Board of Appeals of Cumberland County.

8. **FEES**

- 8A. The annual registration fee for life hazard uses shall be in accordance with the Uniform Fire code of the State of New Jersey.
- 8B. The application fee for a permit shall be in accordance with the Uniform Fire Code of the State of New Jersey.

8C. Non-Life Hazard Uses

(a) In addition to the registrations required by the Uniform Fire Code, the following non-life hazard uses shall register with the Bureau of Fire Prevention. These uses shall be inspected once per year and shall pay an annual fee as set forth below:

- (b) R-A uses shall be inspected and charged a fee only upon sale or change of tenant.
- (c) Uses not classified above that are subject to the Uniform Fire Code will be classified as business uses.
- 8D. (a) Given the limited and specialized use, registration fees relating to farms or strictly agricultural use shall not exceed \$100.00 on an individual farm or property.
- **Section One.** Repealer. All former Ordinances of the Township of Greenwich which are in conflict with the provisions contained in this Ordinance are hereby repealed upon the adoption of this Ordinance.
- **Section Two. Severability.** If any part or parts of this Ordinance are held to be invalid for any reason such decision shall not affect the validity of the remaining portions of this Ordinance.
- **Section Three.** This Ordinance shall take effect after final approval and publication as required by law.

A recent fire inspection of the fire house has determined that there are eight (8) interior doors that need to be replaced. A violation notice has been issued. Mr. Carr was directed to send correspondence requesting additional time to abate the violation.
