Approval of Minutes –

August 5, 2019 - On motion of Mr. Pisarski, seconded by Mr. Lamanteer to approve said minutes, carried with two (2) abstentions by Mr. Henry and Mr. Bostwick.

September 9, 2019 – On motion of Mr. Bostwick, seconded by Mr. Pisarski to approve said minutes, carried with four (4) abstentions by Mr. Henry, Mayor Reinhart, Mr. Lamanteer and Ms. Bacon.

Applications -

Application No. 7-2019 – Historic District Application 251 Tindall Island Road – Block 24 Lot 1.03 – demolition rear of house- seal and preserve front of structure. Mr. Mednick testified the front portion of the house is a single gable roof and the rear portion addition sits under the eave. The floors are of different elevation. It is his intent to preserve the original portion of the house. Once the rear is demolished the front portion will be sealed and weatherproofed and the rear of the structure will also be sealed. The windows will be reinstalled. Mr. Mednick stated that dumpsters will be present. He was advised the property is considered vacant. After review and discussion on motion of Mr. Pisarski, seconded by Mr. Riley to conditionally approve the application, unanimously carried.
